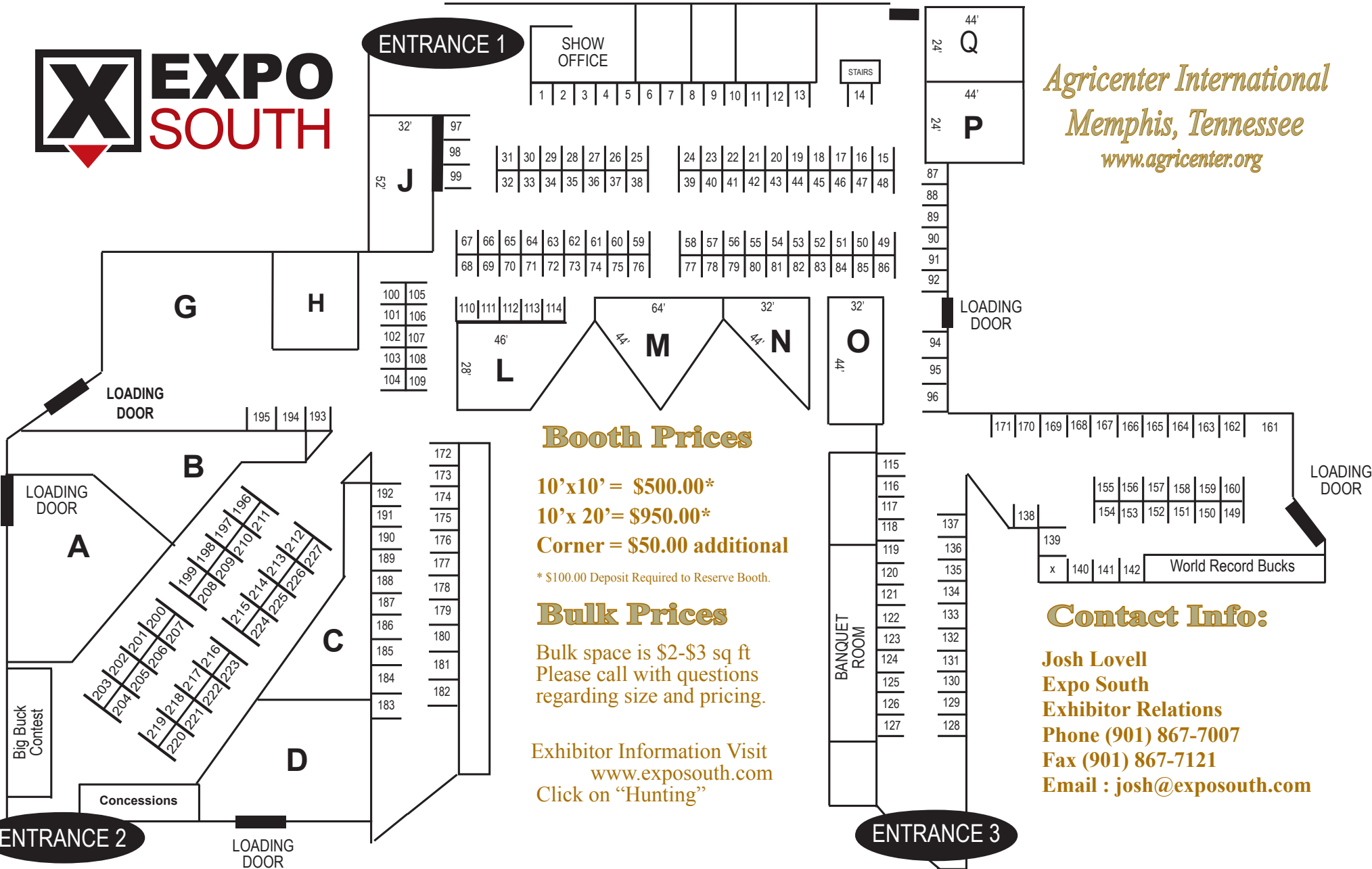

Booths come standard with back and side draping. Hicks Convention Services will serve as the Convention Service Company. Vendors will receive a services packet in order to order tables, chairs, etc

All utilities must be ordered through the Agricenter (see website for the utility request form)

Four exhibitor passes will be given to all booth exhibitors and seven passes will be given to bulk space exhibitors. Additional passes may be purchased for \$5 for each.

Please sign this **COMPLETED** application and mail it Expo South. A minimum \$100.00 (Booth Space) or 10% (Bulk Space) deposit to reserve your space. No space is confirmed until deposit is received & you are notified of booth number. Make checks payable to: **Expo South**.

Full payment is due by June 15, 2010. All space not paid in full by June 15, 2010 will be assessed a 10% late fee. Contract may be cancelled no later than June 15, 2010 without penalty. Cancellations after July 1st, 2010 result in full payment being due as well as any unpaid balance.
